The Cathaoirleach extended the condolences of the members to the family of Sean Nyhan, former Councillor of South Tipperary County Council from 1999 to 2009, member of Clonmel Corporation and former Mayor of Clonmel on 4 occasions. A special meeting had been held by Clonmel Borough Council in his honour on the 11th February. The meeting would be adjourned for a period of 5 minutes as a mark of respect.

Cllr Michael Murphy, Mayor of Clonmel, said that Cllr Nyhan had been an outstanding public representative, educator and first and foremost a family man. He joined in the condolences to his children Frank, Clare, Brendan, Emer and Colin. Sean had been Mayor of Clonmel in 1972, 1979 1989 and 2001. He was first elected in 1968 to Clonmel Corporation and served for 36 years. He was a member of South Tipperary County Council for 10 years during that period. He had been held in the highest regard and left a positive legacy behind him. The advancement of Clonmel had been his primary objective. He was also the first principal of St. Oliver's National School in Clonmel.

Members were informed that an invitation had been received from the Tipperary N & B Association of New York for the Cathaoirleach and Chief Executive travel to New York for St. Patricks Day Events in New York.

Item 5.1

Section 183 Notice - Disposal of Cahir Tourist Office, Castle Street, Cahir to National Tourism Development Authority (Failte Ireland)

It was proposed by **Cllr. A Moloney**, seconded by **Cllr. M. McGrath** and resolved: -

“That in accordance with the provision of Section 183 of the Local Government Act, 2001, Tipperary County Council hereby approves of the disposal by way of lease of property known as Cahir Tourist Office, consisting of circa 0.0074ha, situated at Castle Street, Cahir, Co. Tipperary to National Tourism Development Authority (Fáilte Ireland), in accordance with the terms of the Notice under the above Section, as circulated on the 3rd February”.

This notice was in respect of a lease agreement with Fáilte Ireland on the purpose-built stand alone Tourist Office had expired and the proposal was to extend the tenancy by a further 2 years lease agreement, ensuring the provision of the Tourist Office in Cahir

Cllr A. Moloney referred to maintenance works required to the building and queried whose responsibility it was to have these works carried out. It was agreed to revert to Cllr Moloney in this regard.

Item 5.2

Section 183 Notice - Disposal of property adjacent to Clonakenny, Roscrea, to Clonakenny Tidy Village Group

It was proposed by **Cllr. S Lee**, seconded by **Cllr. M. Smith** and resolved:

“That in accordance with the provision of Section 183 of the Local Government Act, 2001, Tipperary County Council hereby approves of the Section 183 Notice for approval to lease the lands adjacent to playground in Clonakenny for a period of 10 years, in accordance with the terms of the Notice under the above Section as circulated on Thursday 3rd February, 2022.”

This Notice was to comply with a request by Clonakenny Tidy Village Group for the lease of land for the development of community gardens. This property was a small parcel of land adjacent to the existing playground.

Item 5.3

Section 183

Notice -

Disposal of land at

Garrynatineel, Ballina to John & Elizabeth Young

It was proposed by **Cllr. P. Bugler**, seconded by **Cllr. J Carroll** and resolved: -

“That in accordance with the provisions of Section 183 of the Local Government Act, 2001, we hereby approve of the disposal of circa 30.235 sqm of land at Roulagh Junction, Ballina as contained in Folio TY 67064F to John and Elizabeth Young in accordance with the terms of the Notice under the above Section as circulated on the 14th February, 2022”.

Clare County Council were acting on behalf of Tipperary County Council as a Roads Authority by agreement for the Killaloe By-pass, Shannon Bridge Crossing and R494 Improvement Scheme. A Notice to Treat had been issued to the Young's initiating the acquisition phase of the compulsory purchase. Compensation agreement had been reached with the Young's which included the transfer of circa 0.003ha (30.235sqm) of lands owned by Tipperary County Council.

Item 5.4

Local Authority own development – Church Street, Templemore.

The Chief Executive's Report had been circulated to the members in relation to a development at Church Street, Templemore.

Planning permission was being sought for the proposed demolition of 2 No. existing single storey end of terrace houses and the construction of 4 No. one bedroom apartments contained in 2 No. new end of terrace units in their place at 18 & 19 Church Street, Templemore. The new development has been designed to remove two existing single storey derelict properties and replace them with two new two storey units that are in keeping with the predominately two storey streetscape of Church Street. The Housing Section have amended same to be 1 x single storey unit on both sites.

In accordance with Part 8 of the Planning and Development Regulations 2001, as amended, Tipperary County Council made available for inspection plans and particulars of the proposed development together with the project Appropriate Assessment Screening and Environmental Impact Assessment Screening Documents from Thursday 28th October 2021 to Friday 26th November 2021.

1 No. group submission was received by the County Council signed by 17 local residents. A summary of the submission in addition to the consideration and recommendation of the Chief Executive were included in the report circulated.

It was considered that the change of design recommended by the Housing Section, together with the implementation of the requirements and conditions as set out under Section 11 of the report would address the issues raised in the submission received

The Planning Authority was satisfied that the proposal, subject to considerations being implemented, was in accordance with the Templemore and Environs Development Plan, 2012-2018 (as varied) and would not impact on the visual amenity of this area, was acceptable in terms of access, was acceptable in terms of drainage, presented no significant impacts on the conservation objectives of the Natura 2000 site within 15km of the site and presents no flood risk issues.

The development as set out on the plans and particulars was considered acceptable and was consistent with the principle of the proper planning and

sustainable development of the area. Therefore, it was recommended that the proposed development should proceed subject to the recommended requirements and conditions

It was proposed by **Cllr. N. Coonan**, seconded by **Cllr. E Moran** and resolved: -

“That the development as proposed in the Chief Executives report be proceeded with subject to the requirements and conditions contained in the report.”

Item 6.1

Consideration of Management Report

The Cathaoirleach referred to the Management Report as circulated with the Agenda noting that the reports related to the Directorates based in Nenagh and any queries/clarifications would be dealt with by the relevant Director of Services.

Roads, Transportation, Health & Safety

Mr. Marcus O’ Connor, Director of Services and Mr. Liam Brett, S. E. responded to queries raised.

Local Roads

Cllr Bugler referred to the poor condition of local roads in her area. It was noted that notification of the Non-National Roads allocation was expected in the coming week.

Taking of Estates in Charge.

The taking of estates in charge was being carried out subject to funding. Works were being carried out in some estates under the Active Travel Programme and the Council would continue to examine funding streams.

R494 Improvement Scheme

It was noted that the R494 would be closed to traffic for a period due to improvement works and this would result in increased traffic on the R496. The condition of this road would be examined in view of this.

National Roads

Cllr S. Ryan referred to the need for increased funding to improve the condition of the former N.8 and a section of the N62 between Kylenee and Thurles. He was informed that it was possible to consider roads which were subject to taking diverted traffic from the M7 and M8 for strengthening works and these sections of road would be examined and discussed with the Department.

Hedge-cutting.

In response to requests to advertise the ban on hedge cutting from the 1st March, members were informed that an awareness campaign began in September and continued throughout the hedge cutting season. The ban on hedge cutting between the 1st March and the 1st September was a law under the terms of the Wildlife Act.

Waterford Airport

Cllr Ambrose welcomed the granting of planning permission to Waterford Airport to extend its runway and it was hoped this would attract

commercial airline carriers. This Council would welcome this critical piece of infrastructure for the region.

Public Lighting

Cllr J. Ryan requested that the Public Lighting Policy be altered to allow additional public lighting at various frequently used locations. Members were informed that the current policy aimed to reduce energy consumption and lower carbon emissions in line with government policy. The programme to upgrade public lighting to LED was ongoing. It was not the policy of the Council to provide additional lights and infill lighting in speed limit areas could only be considered under the Public Lighting Policy.

Kilganny Bridge

In response to a query by Cllr M. McGrath regarding emergency works required to this Bridge, members were informed that the District Engineer was proceeding to get tenders for the necessary works and were hopeful that funds would be available.

N52

Cllr H. McGrath requested that consideration would be given by TII to the lowering of the speed limit and the granting of access to new developments on this National Secondary Road in view of its proximity to Nenagh. Members were advised that TII did not allow developments access onto national roads for safety and capacity reasons and would not be in favor of lowering the speed limit on this road. Cllr McGrath expressed his dissatisfaction with this policy. This section of road had become an orbital route for Nenagh

School Wardens

In response to a request by Cllr A. Ryan for the provision of a School Warden at Monard, members were informed that due to cost implications additional school wardens were not being recruited. The provision of appropriate school zone warning light systems could be considered if deemed necessary.

N74 Ballyhusty Realignment

It was agreed to consider the request of Cllr Ml. FitzGerald for drainage issues to be addressed as part of this realignment scheme.

N.24

Cllr Ml. FitzGerald sought clarity on the current status of development on the route of the N.24, particularly in relation to sterilised land and the provision of a By-Pass for Tipperary Town. He was disappointed that a meeting had been granted between the Minister and Dail Deputies regarding this important infrastructure for Tipperary but elected members from Tipperary had been excluded from such a meeting.

Cllr S. Ambrose said that the lack of funding for the advancement of the Cahir to Waterford Scheme was of huge concern and families who wished to build on family properties were in limbo due to the sterilisation of lands on the route. Cllr P. English referred to the need to have the sterilisation of lands issue resolved.

Mr. Joe MacGrath, Chief Executive, acknowledged the concerns of members

in relation to the N. 24. and he shared those concerns. At the last meeting of Tipperary County Council, he had spoken about the prioritisation of this project for Tipperary and the entire South East region. Mr. MacGrath restated the position of Tipperary County Council which was adopted by the Council by resolution at their meeting in May, 2022 and that was that Tipperary County Council fully supported the development of the entire corridor from Limerick to Waterford which was being carried out in two phases, Limerick Junction to Cahir and Cahir to Waterford. Members were aware that Tipperary County Council was the lead authority for the Limerick Junction to Cahir Scheme, an allocation of €1m had been received to progress the planning of that and it was hoped that in the next 2/3 months we would see the preferred route for that section. There was also a second motion adopted at that time that when that section of road was progressing, that the section of road around Tipperary Town would be prioritised in terms of the construction.

Kilkenny County Council were the lead authority for the Cahir to Waterford scheme and since Tipperary County Council had been informed that Kilkenny County Council had received no allocation for that scheme, a number of actions had been taken. It was debated at this Council's January Monthly Meeting, the five Cathaoirigh and Chief Executives of the South East Local Authorities had met to discuss the issue, they had also invited the Oireachtas members from the South East to meet and their support was sought. Across the board there was unanimous support for continuing the planning stage for that particular section of the project.

As a result of those meeting a request had been sent to the Minister to seek engagement on the issue. Financial support for Kilkenny County Council would continue to be sought to continue the work started. Approximately two year's work has been put into the planning of the scheme and Kilkenny County Council should receive the financial support to be allowed to bring that scheme to planning and final determination by An Bord Pleanala. The position of the Council was unambiguous and unequivocal, in that the entire corridor needs to be developed and that position was supported by the five South East Local Authorities. This Council would continue to press for engagement with the Minister and Mr. MacGrath confirmed he had made direct contact with the Department on the issue and highlighted concerns. The genuine concerns expressed by the members around the hiatus this caused along the planning corridor was noted and the solution to this was that Kilkenny County Council would be given the allocation to allow them continue the planning of the road and it was important that we would continue to adopt that as the position of this Council, as it was the position of Kilkenny, Waterford, Carlow and Wexford as well. The matter was very high on the agenda and the Council would continue to liaise and try and get a more positive decision and remove the uncertainty that currently exists.

Planning

Mr. Eamon Lonergan, A/Director of Services, and Ms. A. Devaney, S.E.P., responded to queries raised as follows: -

Pre-Planning Meetings.

It was confirmed that “in person” pre planning meetings were scheduled to resume from the 21st March and members should contact the Senior Executive Planners to confirm details. Interest had been expressed in a hybrid model of preplanning meetings and this was being facilitated.

E-Planning

It was noted that 30% of applications received to date in 2022 had been made through the new e-Planning system.

Ballina WWTP

It was agreed to examine particular wastewater connection issues in respect of specific planning permissions highlighted by Cllr Bugler.

Draft County Development Plan Workshops.

The Draft County Development Plan had been on display from the 30th July 2021 to 15th October, 2021. 615 submissions had been received and the forthcoming workshops would take members through the submissions received and the draft Chief Executives Report.

In response to queries regarding planning permission for one-off dwellings on family land, members were informed that the draft plan did accommodate family members that needed to reside in a specific area in particular circumstances and this would be for discussion at the workshop to be held on the 22nd February.

The Cathaoirleach advised members that it was necessary to cancel the Planning Workshop on the 18th February and reschedule owing to the launch of the Mid West Regional Enterprise Plan by the Tánaiste in Nenagh on that day.

Congratulations

Mr. Joe Mac Grath, Chief Executive, informed members that Mr. Eamon Lonergan, had been appointed to the position of Director of Services and extended congratulations to him.

Fire & Emergency Services

Mr. Brian Beck, A/Director of Services responded to queries raised as follows: -

Fire Service

Cllr S. Ambrose thanked the Fire Service for their swift control of a recent fire in the former Clonmel Arms Hotel.

Templemore Fire Station

It was agreed to follow up an Invitation extended to the Minister to open the refurbished Templemore Fire Station.

Fire Crew support for Ambulance Service

Cllr J. Ryan queried the merits of introducing a policy whereby trained fire crews would respond to emergency ambulance calls if an ambulance was not available at that time. In response Mr. Beck advised that emergency medical response was a core activity of the HSE and not the Fire Service.

However, this did not prohibit the Fire Service from responding to an emergency. A change in policy was a national issue and this Council would comply with any national direction received.

Library & Cultural Services

Mr. Brian Beck, A/Director of Services responded to queries raised as follows: -

Clonmel Library Renovation Project.

The tendering process to appoint a full design team was almost complete and it was expected that tender documents will be issued in the next week. It was anticipated that a Part 8 would be brought before the members later in 2022. It was noted that funding had not yet been secured for the construction works. It was the proposal of the council to have a detailed design, planning permission and costing in place in advance of further engagement with the department for funding.

Libraries – Covid 19 restrictions.

Members were informed that all restrictions in Libraries had been lifted except for mask wearing and hand sanitising. Meetings Rooms were currently being surveyed with CO2 monitors to ensure that air quality was appropriate to prevent the spread of Covid-19.

Finance & Information Technology

Tipperary Town Revitalisation Project

Cllr M. Hanna Hourigan welcomed the recent announcement of funding for the Tipperary Town Revitalisation Project.

Item 6.2

Public Sector Duty Strategy & Action Plan and Executive Summary

Members were informed that Public Bodies, including Tipperary County Council, were required to set out in a manner that was accessible to the public in its strategic plan an assessment of the human rights and equality issues it believed to be relevant to its functions and purpose and the existing or proposed policies, plans and actions to address those issues.

A graphically designed document had been produced and circulated to the members for their information. It would be circulated to staff and published on the Council's website for public access. A short executive summary had also been produced and translated into Arabic, Polish and Portuguese to assist in dissemination to the many migrant communities in the county. These would also be placed on the Council's website.

Public bodies would be required to report annually on developments and achievements in that regard in its annual report in a manner that was accessible to the public.

This was noted by members.

Item 9.1 Notice **of Motion**

Cllr S. Morris **(Ref: 2349)**

It was proposed by **Cllr. S. Morris**, seconded by **Cllr. R Molloy** and resolved: -

"There are 82 children with Spina Bifida and/or Hydrocephalus currently requiring urgent Orthopedic intervention. This was brought to the attention of the Minister for Health Stephen Donnelly's in December 2020 (1). However, no action has been instigated by the Minister to resolve this matter and these children deteriorate. Lack of surgical intervention has caused their limbs and bodies to become deformed and maimed. Some of these children's legs are so badly affected that the soles of their feet permanently rub together causing open sores and bleeding.

Children who have the ability to walk are losing or have lost that ability due to the absence of timely surgical management. Others who are manual wheelchair users, due to the same issue are unable to self-propel themselves effectively leaving them immobile. The lack of timely surgical intervention means that effectively these children end up requiring more complex surgeries and failing that amputation of limbs.

I am calling on the County Council to write to the Minister or Health, Stephen Donnelly and fast track these children for surgical review as a matter of urgency. We are also calling on the Minister for Health to ensure that provision of services is made to Disabled

Children within elective hospital settings as well as acute hospital settings to avoid a repeat of this situation in the future”

Members supported the motion and it agreed to refer the motion to the Minister for Health, Mr. Stephen Donnelly for comment/response. It was proposed by **Cllr. M. Smith**, seconded by **Cllr. S. Lee** and resolved:

Hybrid Meetings.

In response to an enquiry by Cllr A.M. Ryan, Mr. G. Walsh, Meetings Administrator, confirmed that Council Chambers in Clonmel and Nenagh would be fitted with appropriate technology to facilitate hybrid meetings. Subject to testing it was the intention that hybrid meetings could be facilitated from March, 2022.
