Ann Marie Devaney, Senior Executive Planner was in attendance for this item and Fergal O'Donnell, Executive Planner attended via zoom. A Chief Executive's Report on the Part 8 Public Realm Refurbishment and Enhancement at Gantly Road, Roscrea was circulated to the Members in advance of the Meeting. Fergal stated that the Part 8 proposal is for the re-alignment of Gantly Road. It is intended that the Gantly Road Development will support an Age Friendly neighbourhood as well as active travel measures in the town and it will run in parallel with Housing Section who will develop housing elements to the Gantly Road Development. The Members raised the following queries:

- Assurances are required that Main Street will continue to be developed and that there will be access points from Gantly Road onto Main Street.
- It would appear that existing access routes from Gantly Road onto Main Street are through private business premises.
- There is a concern that Main Street will go unfinished. The development must ensure that connectivity within the town is included.

Replies to queries raised were as follows:-

- Access points from Gantly Road to Main Street have been identified in the Roscrea Master Plan, however the Part 8 is for the re-alignment and renaming of Gantly Road only and access points do not form part of this proposal. Access points will come on line if private owners wish to develop them.
- Roscrea Enhancement Plan is a different scheme entirely and different funding streams will be examined to develop Main street.

It was proposed by Councillor S. Lee, seconded by Councillor M. Smith and resolved:-

'that the Chief Executive's Report on Part 8 – Proposed Development of Gantly Road, Roscrea be and is hereby approved.'

### 4. Update from Environment and Climate Action.

Marion O'Neill, Senior Executive Officer, Orla Kelly, Administrative Officer, Ruairi Boland, Senior Executive Engineer and Colette Moloney, Senior Executive Scientist were in attendance via zoom for this item. An Environment and Climate Action Section Update for the period 01.01.2022 to 31.03.2022 was circulated to the Members with the Agenda in advance of the Meeting. The report outlined the following:-

The Members raised the following issues:-

- Will there be a second roll-out of smart bins within the District? The smart bin in Littleton is replacing numerous bins and appears to be bursting at the seams. A second smart bin and more frequent pick-ups are required.
- When will the Active Travel Office be up and running within the County.
- Dumping blackspots within the MD in areas such as Curraheen, the back of Derrynaflan, Boulick, etc. need to be targeted with mobile cameras which are now permitted under the Law.
- Can the Council run an anti-dumping initiative?
- The Council removed a substantial amount of rubbish not too long ago from the rear of Derrynaflan Drive, Littleton; an estate with approximately 20 houses. More rubbish is now piling up again in this area and a railing around the fort is needed as a matter of urgency to try and tackle the issue.
- Mature trees are causing problems and upset to families in St. Patrick's Cemetery, Thurles with overhanging branches and bird droppings impacting on graves. These trees need to be removed as cutting them back is not effective. Can the MD undertake a survey of such problematic trees?
- Who is responsible for installing the Electric Vehicle charging points as the number of charging points in Thurles is extremely poor despite the increase in sales of electric vehicles.
- There is raw sewage being discharged into the River Suir at the back of Dunnes Stores Shopping Centre in Thurles.
- There are bales of hay and straw as well as rubbish strewn around Carden's Court Housing Estate on the Clonmore Road, Templemore that need to be addressed.
- Weekend litter collection in Templemore town is required as the town is in a disgraceful state every Sunday morning with litter strewn around.

Additional bins need to be installed and more resources need to be input into tackling the litter in the town.

- There is an abandoned burnt out car in Carrig Lane, Roscrea that needs to be removed.
- Can the Council establish a hardship scheme to assist people who are struggling to pay for refuse collection?
- When will the electric vehicle charging points, that are proposed for Slievenamon Road and Parnell Street carparks, be installed.
- There are no Electric Vehicle charging points in Templemore town centre despite assurance that two charging points would be installed in the town. Furthermore, an even distribution of charging points throughout the towns in the District is required.
- Litter picking needs to be re-introduced into Thurles town on Sunday mornings to tackle the litter.
- Will the Council resume the litter surveys of blackspot dumping areas that were taking place pre Covid?
- Can a '*carrot and stick'* approach be used to tackle the issue of derelict buildings within the MD, i.e. support owners who wish to develop derelict buildings and penalise those who will not.

Replies to queries raised were as follows:-

- The roll-out of the smart bins was a one-off scheme. However, if further funding does become available the issue will be looked at.
- The collection capacity and frequency of rubbish from the smart bins can be amended by the Municipal district.
- The establishment of the Active Travel Office falls under the remit of the Roads Section therefore, the issue will be referred to them.
- €80,000 has been made available this year towards anti-dumping initiatives. Areas have been identified and Environment Section are working with Housing Section in addressing this matter.
- The illegal dumping to the rear of Derrynaflan Drive, Littleton is currently being examined and further information will be sought before a solution can be determined.
- 4 chargers 2 double chargers will be installed in Parnell Street carpark, Thurles within the next month.
- Can photographs of the raw sewage being discharged into the River Suir at the back of Dunnes Stores Shopping Centre in Thurles be submitted to Environment Section and the issue will be examined.
- The provision of street cleaning in towns at the weekends is a matter for the MD.
- The burnt-out car in Roscrea will be followed up with the Enforcement Officer to resolve the issue.
- Currently there is no specific Hardship Fund available, such an incentive would be a national initiative. There is currently an option for households to reduce refuse collection costs by having two households agreeing to share a bin.

- Sites are currently being examined to identify EV charging points for Templemore.
- Environment Section will discuss further with Councillors Coonan and Lee, the issue of straw, hey and rubbish being strewn around Carden's Court, Templemore.
- The household surveys in blackspot dumping areas that were taking place pre Covid will re-commence.
- Environment Section have had a number of successes in engaging with owners of derelict buildings within the MD, however it can be difficult to establish ownership of a property. There are dedicated staff working on dereliction in conjunction with the Vacant House Officer.

- Can a Sensory Room for children with Special Needs be set up within Thurles Library, similar to the one in Limerick Library which has proven to be a tremendous success.
- What is the update in relation to the first 5 library initiative.
- Have all library study facilities for students resumed to full capacity?
- Can the Library liaise with the GAA in relation to the creation of a National GAA Museum in Thurles town.

- Can Templemore Cultural and Library activities be included in subsequent reports as it appears to have been omitted from the current report.
- The exceptional research work undertaken by Dr. Des Murnane and Mary Guinan Darmody on the War of Independence and its aftermath was praised by the Elected Members, as a huge body of very important work.

Damien replied to queries as follows:-

- The Sensory Room in Limerick library is the first of its kind in the country . Tipperary Library will examine potential funding opportunities in this regard and revert with an update.
- The *first 5 Library Initiative* is progressing well. Stock has been delivered and is being dispatched to the networks.
- Study facilities for students at all libraries has resumed to full capacity.
- The Library will look to restart talks with the GAA in an attempt to establish a National GAA Museum in Thurles.
- Templemore Library is running well despite the omission from the Library Report. There are still some Covid issues but activities are resuming.
- Rosin O'Grady, Heritage officer was also involved in the War of Independence studies. The report is a tremendous initiative and will stand the test of time.

The District Engineer updated the Members in relation to District Works as follows:-

- The Roads Programme is progressing at pace. There are three macadam crews in operation; two in the southern end and 1 in the northern end of the District. It is anticipated there are approximately 6 weeks left in the Programme.
- CIS Schemes some of them will be included at this juncture, however there have been delays with some offers being declined for a second time.
- LIS review of applications is underway with a closing date of 29<sup>th</sup> April, 2022. The priority list will be based on the agreed criteria scoring system. It will be circulated to Members for comment.
- Surface Dressing Programme is scheduled to commence the first week of May and roads are being prepared in advance.
- Funding has been received from the TII for road maintenance on Brittas Road, Thurles; Gortnagowna outside Roscrea and for footpaths between Priory Place and Park Road in Templemore.
- Roads Central Funding, obtained though Targeted Investment Intervention Red Roads, has been allocated to Dromard Beg outside Clonmore.
- Tertiary Allocation the closing date for agreed submissions to be sent to Roads central is the 25<sup>th</sup> April. Members' submissions should be sent in as soon as possible so that contractors may undertake the works at this juncture while they are in the area.

- GMA works Killea works were ongoing yesterday and picnic benches at agreed locations have been erected in Toomevara which was part of last year's GMA works.
- Works to Parnell Street and Ulster Bank carparks under Development Levies are substantially complete with the installation of EV Chargers remaining to be completed in the coming weeks.
- OPW funded works in Galbertstown, to address seasonal flooding issues to the local road, have been completed.
- Active Travel funded footpaths in Kennedy Park, Roscrea are complete.
- Phase 1 of Irish Public Bodies funded footpath improvement works in Rosemount, Thurles is complete. Currently reviewing further locations for Phase 2 works both in Rosemount and in Thurles town.
- ORIS funded works for the River Suir Walk well under way with the Mill Road section nearing completion and works on the Ladies Well section commencing this week. It is anticipated that both sections will be fully open to the public in 3 to 4 weeks.
- Built Heritage funding has been obtained for the refurbishment of Rosemary Square Fountain, Roscrea. Consultation with the Conservation Architect will take place regarding the proposed works for the project.

The Members raised the following issues:-

- Remedial works are necessary on Slievenamon Road, Thurles until such time as the Slievenamon Road Improvement Works take place.
- The parameters for parking, including all-day parking, in Slievenamon Road carpark, Thurles need to be re-examined.
- The staggered junction on the N62 Birr Road, Roscrea is a busy national route, which is dangerous and needs to be examined immediately.
- The lines on the Zebra Crossing at Two Mile Borris have faded considerably and are difficult to see.
- The verges at Pouldine Cross need to be examined.
- What is the update in relation to works on the entrance to the Templemore Pitch and Putt Course.
- Issue of flooding on Patrick Street, Templemore needs to be examined.
- The flashing speed signs at Rahealty are not working.
- What is the lifespan of windows and doors new doors and windows are needed in Gortataggart.
