Roscrea Local Area Plan 2023-2029

Mr. J. Flood, District Planner, made a presentation to the members on the process to date, noting the following: -

Tipperary County Council commenced the process of preparing a new Local Area Plan (LAP) for Roscrea on 24th February 2023. The Draft LAP was made available for a period of 6 weeks from 24th February 2023 to 11th April 2023 and submissions were invited from stakeholders and the public during this time. 19 submissions had been received.

A report had been circulated which provided a summary of the submissions and observations received during the public consultation process and provided the Chief Executive's considerations and recommendations on the submissions and observations received.

The report was set out over two parts:

- Part 1 set out the process, legislative requirements, submissions received and the consideration and recommendations on these submissions.
- Part 2 provided a detailed list of all recommended changes to the Draft LAP arising from the consideration of submissions received.

A workshop was held in the Thurles MD offices on 23rd May 2023 to discuss the CE report and proposed amendments to the Draft Roscrea LAP.

A further 5 no. proposed amendments to the Draft Roscrea Local Area Plan 2023-2029 were proposed (members amendments) which were additional to the amendments recommended in the CE report. The additional amendments were as follows: -

Amendment 1

Amend the zoning matrix (Table 9.2 of the Draft Roscrea Local Area Plan 2023-2029) as it relates to the Town Environs zoned land use zone to allow sports and leisure facilities to be Open for Consideration (from Not Normally Permitted).

Reason

To allow flexibility to develop new sporting and leisure facilities on lands zoned for Town Environs and to extend existing facilities onto Town Environs zoned lands.

Amendment 2

Amend subsection 4. North of the Train Line of Section 5.2.1 Roscrea Neighbourhoods of the Draft Roscrea Local Area Plan 2023-2029 to include for the following additional text (red text is additional):

4. North of the Train Line

This area is more accessible to the town centre than the area south of the N62 and is more accessible to the rail service. However, easy links into the town centre are limited by the rail line. The area is more open with gentle topography, than the medieval centre of the town, and there may be scope for investment in walking and cycling to improve accessibility with the town centre. The Council will work with its active travel team to improve connectivity with the town centre. In addition, the provision of walking and cycling facilities connecting the rail station to Ashbury rail crossing to be examined.

Reason

To include for a provision within the LAP to examine the potential for east/west pedestrian/cycle linkages from the Roscrea rail station and Ashbury rail crossing.

Amendment 3

Amend Objective 5C of the Draft Roscrea Local Area Plan 2023-2029 to include for the following additional text (red text is additional): Develop, in conjunction with the Council's Active Travel Team, interconnectivity and linkages within, and between the neighbourhoods as identified as in Section 5.2.1 and the town centre, the train station,

employment areas and local schools, including the provision of walking and cycling facilities to the Ashbury rail crossing.

Reason

To include for a provision within the LAP to examine the potential for east/west pedestrian/cycle linkages from the Roscrea rail station and Ashbury rail crossing.

Amendment 4

Amend bullet point 3 under the Key Planning Criteria for regeneration site 5. Birr Road, Appendix 3, Schedule of Regeneration sites to include for the following additional text (red text is additional):

• A Masterplan should consider providing sufficient pedestrian / cycle and vehicular linkages and permeability through the site, to adjoining lands to the southwest, also through to 'Strategic Reserve' lands to the north west, and east to the town centre, with consideration for a pedestrian bridge over the railway line to connect through lands on the west side of Gantly Road, as indicated in the Gantly Road Age Friendly Masterplan.

Reason

To include for provision to allow for active travel and vehicular linkages with lands to the southwest of the regeneration site.

Amendment 5

Amend Appendix 4 of the Draft Roscrea Local Area Plan 2023-2029 to replace the initial draft version of the Roscrea Town Centre First Plan with the most up to date draft version of the Roscrea Town Centre First Plan. Reason

An initial draft version of the Roscrea Town Centre First Plan was circulated as part of the Chief Executives report. This change is to ensure the most up to date draft of the Roscrea Town Centre First Plan issues as a proposed material alteration to the Draft Roscrea Local Area Plan 2023-2029

A resolution of the members was required where it was proposed to make or amend the plan otherwise that as recommended in the Chief Executives report. Amendments in the CE report and additional amendments were considered material alterations and would require a further round of consultation.

Cllr M. Smith, acknowledged the engagement of the Planning Department with the elected members throughout the process. He proposed a further amendment to the plan in respect of the rezoning of a section off the Limerick Road from Employment use to town environs use. The reason for the proposed amendment was to balance regional development as part of the town.

The proposal was seconded by Cllr S. Lee. Reason for change – to balance regional development as part of the town.

Cllr N. Coonan referred to the 19 submissions made and said that some people were not happy with the responses given and referred in particular to lands on the Birr Road. He referred to matters of concern which included the relationship between the Local Area Plan and the Town Centre First Plan and the connectivity between Main Street, Roscrea and Gantly Road and that there would be balanced development on the north western side of town within approximately 500 metres of the town centre.

Mr. J. Flood, confirmed that the Town Centre First Plan was incorporated under the Local Area Plan as an appendix which would allow the plan to be given a statutory footing as part of the Local Area Plan. Therefore, the objectives in the Town Centre First Plan became objectives of the Local Area Plan

With regard to the lands on the Birr Road, members were informed that the processes that informed designation of lands for residential, obliged the Council to undertake serviced land assessments to determine the appropriate designations for residential lands and land west of town on the Birr Road were subject to that. There was a portion of lands, a former quarry that was identified for regeneration zoning which could be residential led regeneration but lands further west had been zoned strategic reserve and that decision was made following the undertaking of the serviced land assessment.

Mr. Joe MacGrath, Chief Executive, confirmed that the next part of the process, which would include the amendment proposed by Cllr M. Smith, was that the material amendments would go out for further consultation, there would be further meetings at District level and the Plan would be brought before the members at the plenary meeting on the 11th September, 2023 for final adoption. The Chief Executive emphasised the importance of continued engagement throughout the process and the importance of these plans to local areas.

Roads & Transportation, Active Travel, Health & Safety

Mr. Marcus O'Connor, DOS and Mr. Liam Brett, S.E responded to queries raised as follows: -

Speed Limit Review

A county speed limit review would take place once national speed limit guidelines were issued as this may change default speed limits on national, secondary and local roads. It was noted that consultation with Gardai did take place in respect of problematic locations where speed limits were not being obeyed.

Suir Blueway-Waterford Greenway Link

The concept and feasibility study for this project was under development.

N24 Moangarriff to Twomilebridge Pavement and Traffic Calming The planning process for this project would commence following TII technical approvals.

EV Charging

Members were informed that 13 new fast electric vehicle (EV) charging stations were being installed throughout the County in 2023 which would provide 18 charging points. It was noted that Local Authorities were to prepare an Electric Vehicle Charging Infrastructure Strategy which would likely involve public consultation.

N24 Cahir to Limerick Junction

Members welcomed clarification received of funding for the progression of the N24 Cahir to Limerick Junction project. A designated website was available to provide up to date information on this scheme.

Local Link Service Thurles to Clonmel

It was agreed to liaise with the Department regarding proposal for the introduction of a local link service from Thurles to Clonmel.

Clonmel Town Bus

It was confirmed that the National Transport Authority (NTA) were the responsible authority for the provision of a town bus service in Clonmel.

Relocation of bus stop at Kickham Street, Nenagh.

It was confirmed that the relocation of this bus stop was under consideration with the National Transport Authority.

Safe School Route Programme

It was agreed to liaise with the NTA regarding future funding of the safe school route programme.

Thurles Inner Relief Road

Funding for the design stage of this project had been received and negotiations with landowners on the route were ongoing.

Road Safety - Deer

A number of members spoke of the danger to road users from deer and also the damage being caused to farm crops. It was agreed to write to the Department of Agriculture regarding this issue.

Noise Pollution M8

Cllr M. McGrath sought clarity on the responsible authority regarding possible noise pollution affecting a residence adjacent to the M8 and it was agreed to obtain further details of the location of the property concerned.

Roadworks Knockavilla

Cllr Kennedy referred to road diversion signage issues at recent roadworks in Knockavilla and it was agreed to raise this matter with the District Engineer.

Public Lighting

The upgrade of existing public lighting to LED across Tipperary under the National Public Lighting Energy Efficiency Project would commence later this year as a contractor had been appointed and surveys had commenced.

Ardfinnan Bridge

Cllr Anglim sought assurance that the Council would continue to seek funding to progress the Ardfinnan Bridge Project following the recent statement by the The National Transport Authority (NTA) that it was not in a position to support or fund an independent walkway at the Bridge and had removed it from its 2023 list of projects. Members were advised that the Council would continue to work with the community in Ardfinnan, the elected representatives and the NTA to get past the current impasse.

Planning & Development

The Cathaoirleach advised members that he proposed to take Item 10.1 Notice of Motion Ref 2624 with the Planning and Development Directorate.

County
Development
Plan - Small
Rural
Enterprises.

We are calling on Tipperary County Council to review its policy for small rural enterprises in the countryside contained in the County Development Plan 2022. This Policy is having an adverse impact on the future of families engaged in rural enterprise.

The Motion was seconded by Cllr. N. Coonan.

The reply to the Motion was noted as follows: -

The Tipperary County Development Plan 2022-2028 provides a framework for a thriving rural economy, through support for diversification and innovation to sustain and strengthen our rural communities. The plan supports small scale rural enterprise outside of settlements to facilitate a

start-up entrepreneur in or adjacent to the home. The plan further supports rural enterprise through farm diversification into alternative onfarm and off-farm activities and the development of tourism and tourism accommodation in the County.

Section 8.4 of the Draft Plan recognises the importance of, and supports rural enterprise. In particular Section 8.4.4 supports start up enterprises while Section 8.5 supports appropriate levels of expansion to existing enterprises. These supports are reiterated in Planning Policy 8-5 and 8-9 respectively.

The Councils support for rural enterprise is further endorsed in Section 7.3 and Planning Policy 7-4 regarding farm diversification and in Section 9.4 and Planning Policy 9-1 and 9.2 which supports tourism development.

Cllr M. Smith expressed his disappointment with the current Development Plan which he said was having an adverse impact on rural development and this had been highlighted by a recent planning application in his area.

Cllr N. Coonan spoke of the need to protect services being provided in rural areas.

A number of members spoke in support of the motion and following discussion it was agreed that a workshop would be held with the members to identify specific constraints within the existing plan and establish if further amendment was required which would necessitate a variation of the existing plan.

Planning and Development

Ms. A.M. Devaney, S.E.P., responded to gueries raised as follows: -

Modular Homes

It was confirmed that the Local Authority were obliged under legislation to act on complaints received in relation to unauthorised modular homes. A workshop had been held with members in relation to Modular Homes clarifying the Council's position.

Section 57 Declarations

It was noted that some owners of protected structures were experiencing difficulties in meeting timelines associated with declarations issued under Section 57 of the Planning and Development Act, 2000. A declaration under Section 57 did not prejudice the application of Section 5 of the Act which on payment of the prescribed fee would allow the owner to receive a decision and review by An Bord Pleanala.

Members were made aware that a free seminar was being held in TUS Thurles Campus on the 17th June, 2023 regarding the process of bringing vacant properties (historic and non-historic) back into use.

Knocklofty House

It was confirmed that the Council would engage with the receiver and any new owners of Knocklofty House to ensure their awareness of the protected status of the building.

<u>Cluster Housing Model – Kilsheelan</u>

A decision by the Department to the business case for this development was awaited.

Cahir Town Centre Regeneration Strategy

Funding had been announced under Phase 2 of this project and an update would be sought in relation to timelines.

Conservation Architect

A decision had not been received to date from the Department in relation to the position of Conservation Architect.

Just Transition Scheme

It was noted that a response was awaited in relation to the members request to the Minister to have the Lower Ormond area within the Nenagh Municipal District included in the scheme.

Fire & Emergency Services

Mr. D. Carroll, A/Director of Services, responded to queries raised as follows: -

Sacred Heart Convent, Roscrea

Reference was made to the proposed housing of refugees in the former Sacred Heart Convent in Roscrea and it was confirmed that fire safety requirements for this site were currently being processed. Nenagh District Members expressed their dissatisfaction with the level of engagement that had taken place in relation to the proposed use of the building. Following discussion it was agreed to write to the Minister to request a meeting with District Members and community representatives regarding the provision of refugee accommodation in Roscrea.

National Industrial Action – Retained Fire Fighters

Members were advised that escalating industrial action commenced on 6th June, 2023 with a work to rule and non co-operation with training. From the 13th June there would be rolling strikes to 50% of fire stations on a rotation basis and contingency plans were in place whereby calls would be picked up by the remaining stations. Engagement was ongoing with the strike committee to minimise disruption to the public. The public were advised to continue to dial for emergency services. In the event of an all out strike the fire service would respond to all emergency calls involving life-threatening situations. Members would be kept advised of this evolving situation in the Fire Service.

Library & Cultural Services

He always protected the finances of the Council and had worked at a national level to secure the position of Tipperary County Council. The Chief Executive wished Mr. McCarthy a happy, long and fruitful retirement.

Mr. McCarthy, thanked members and the Chief Executive for their kind comments. He said he had worked with a good team in the Finance and I.T. Sections and enjoyed a good working relationship with his fellow colleagues, Directors of Services, Section Heads and members. He had enjoyed his career and wished everyone success in the future.

In addition, I respectfully ask for your support to petition the Minister to expand the Croí Cónaithe Scheme to owners who wish to renovate vacant or vacant homes confirmed derelict, subject to conditions that the property is subsequently used for long term occupancy either through a sale or through a long-term lease. Furthermore, that those approved under the existing scheme be included when the changes have been implemented, if they have not yet drawn down their funding".

Clare County Council

"That Clare County Council supports the recent Macra na Feirme campaign, entitled "The Rural Revival, Steps for our Future". This campaign was a march that departed Athy, Co. Kildare at 7pm on Tuesday, April 25th, marching through the night, physically carrying their message, before arriving at Government Buildings circa 1pm on Wednesday, April 27th. The message is simple, Macra Na Feirme members want to be able to remain at home, working and living in their own communities and the key components of their message are as follows:

Accessing affordable housing and cumbersome housing planning guidelines. Disjointed and scare healthcare services for rural communities. No recognition or engagement by Government on a farming succession scheme.

Lack of planning for the future of our rural communities informed by rural people.

Imposition of quotas on young farmers availing of grant aid support. Lack of public transport for rural Ireland.

Proposals to rewet large areas of rural Ireland.

I am also requesting that this Notice of Motion be circulated to all other Local Authorities".
