2. Adoption of Minutes.

The Members raised the following queries:-

- Dumping in rural areas and on approach roads to towns and villages continues to be a problem.
 - Update requested on the technology being used to address the problem.
 - Is it possible to use mechanical methods to remove rubbish from areas?
 - Campaign to bin your rubbish is very welcome and shows the effects of dumping.
 - Update on the interaction with Fast Food Outlets to tackle litter problem.
 - Removal of rubbish immediately could help avoid other rubbish being dumped at the site.
- The provision of further Smart Bins in villages around the District? This
 initiative has been very successful in areas where the bins have already
 been provided.
- EV Charging points infrastructure has been in place in Parnell Street and Slievenamon Road carparks, Thurles for some time. When will the points be switched on?
- Lack of dog waste bins around the District.
- Social Media Campaign on responsible dog ownership what demographic is targeted with this campaign.
 What types of issues are being addressed in the Climate Action Plan being developed by the Council?

Michael replied to queries as follows:

 A lot of work is being carried out to tackle the problem of dumping including:awareness with a more graphic visual impact of the effect of dumping;

focus on discussions with fast food outlets;

- Anti-Litter Awareness Campaign i.e. clean up initiatives.
- Actively seeking funding to run a pilot scheme for the use of mechanical methods to remove rubbish which is very costly.
- Working with community groups i.e. provision of litter pickers, bags etc.
- Continue to support community groups who are doing tremendous work.
- Utilise technology such as cctv and drones.
- Will be more aggressive with prosecutions which is a lengthy process.
- Will continue to work with the Districts to deal with the issue.
- The Climate Action Plan is to be developed by 23rd. February 2024. Claire Ryan has been appointed Climate Action Co-Ordinator. Prior to Claire's appointment a pre-draft plan was prepared with over 2,000 submissions highlighting a number of issues.

The District Engineer advised the Members that only one tertiary submission has been made to date and all submissions were needed as soon as possible. He also advised that approval for funding for work at O'Donovan Rossa Street, Thurles had come through earlier today.

The Members raised the following queries:-

- Traffic islands on the old N8 at Liskeveen were hindering residents from accessing their properties – could this work be undertaken under a Low Cost Safety Scheme?
- Drainage at Horse & Jockey continues to be an issue due to deluges of rain.

- Patch of road on the old N8 Littleton to Horse & Jockey in need of repair.
- Flyover on the N75 National Road in Two-Mile-Borris at the Turnpike is very slippery can the TII be contacted regarding this issue?
- Cross at Moyneard / Moyne is dangerous and needs barriers installed.
 There is some fencing at this location but it does not address the issue.
- Signage needed on the N62 Templemore where St. Mary's National School is it is dangerous for children attending the school as vehicles speed in from the Roscrea Road.
- Footpaths on Patrick Street (outside Doherty Hardware) and on Main Street (outside the old Bank / Garda Station) are in need of attention.
- There are two large potholes on the old N8 road at the roundabout into Cashel which needs attention. Can this issue be passed onto the Tipperary MD whose area this is in?
- Can work on Cuchulainn Road, Thurles be included in the work schedules for O'Donovan Rossa Street?
- Complimented the work carried out on the River Suir walk at Ladyswell, Thurles. However the entrance from Clongour is not wheelchair friendly – can this be addressed?
- Stretch of road on the N62 Derrymore is deteriorating.
- Road in Roscrea Town Centre is deteriorating and in need of repair.
- Road surface outside Brittas Veterinary Clinic on Brittas Road, Thurles in need of repair. There was work carried out on sections either side of this patch.
- Can a centre white line be laid on the roadway from Mill Road to Littleton?
- Can specific parking bays be allocated for motorbikes in Thurles?
- There are sections along Slievenamon Road, Thurles where the roadway between the road and the footpath is sinking particularly outside Ryans Funeral Home.
- Will EV Charging Points be installed before resurfacing work is carried out at The Square, Templemore?
- Road surface on the Suir Bridge at N62 Killough is in need of attention.

The District Engineer replied to queries raised was as follows:-

- The EV Charging Points will be installed in advance of work at the Town Hall, Templemore. The roadworks at this location will include closing of joints and not a full resurface.
- The issue at the Suir Bridge will be examined.
- Contact will be made with the TII regarding pothole outside Brittas Veterinary, Brittas Road, Thurles.
- The provision of centre white line from Mill Road to Littleton will be examined.
- Parking spaces are already assigned to a number of specific groups. We can look at the possibility of assigning specific bays to motorbikes at the Market Quarter, Thurles if it is required.

- The issue with the road verge on Slievenamon Road, Thurles will be monitored. The major works are expected to take place shortly. Repairs have previously been undertaken near pedestrian crossing for public safety.
- The dangerous cross at Moyneard will be examined.
- Some work has already been undertaken on N62 at St Mary's National School however sightlines will hinder the amount of work that can be carried out at this location. Provision of signs identifying school in the area will be taken up with Capital Section.
- A programme of footpaths in need of repairs is being prepared and Patrick Street and Main Street, Templemore will be included.
- Work on O'Donovan Rossa Street, Thurles will depend on funding.
 Some localised areas on the street can be addressed.
- A photo of a proposal to address wheelchair access at Clongour,
 Thurles will be shown to Councillor Hanafin after the Monthly Meeting.
- Stretch of roadway at N62 Derrymore will be examined.
- Funding stream to address deterioration of road at Town Centre,
 Roscrea will need to be identified.
- Drain cleaning is undertaken once the Roads Programme is completed.
- The old National Routes will be examined however there is no funding available.
- Issue with N75 Bridge will be passed onto the TII.

 Contracts with a local contractor for work at Templemore Town Hall are expected to be signed next week. The cost of the project is over €3m with match funding from the County Council with an 18 month expected completion timeframe.

 Signs will be erected advising the public that the toilets in the nearby Sports Clubs are available for use by the public.
 Following a meeting with the Templemore Development Association, it is intended to provide a disability toilet in the new Town Hall and funding is currently be investigated.
