#### 1.1 Disclosures/Conflicts of Interest.

There were no Disclosures/Conflicts of Interest raised at the Meeting.

# 2.1 Minutes of the March Monthly Meeting of Thurles MD.

It was proposed by Councillor M. Lowry, seconded by Councillor E. Moran and resolved:

"That the Minutes of the Thurles Municipal District March 2024 Monthly Meeting which was held on the 25<sup>th</sup> March 2024 be adopted as a true record of the business transacted at the Meeting."

#### 3.1 Update from Environment and Climate Action.

Kieran McKenna, A/Senior Executive Engineer and Michael Moroney, Senior Executive Officer were in attendance for this item. An Environment and Climate Action Update for the period 01/01/2024 to 31/03/2024 was circulated to the Members, with the Agenda, in advance of the Meeting and taken as read.

The Members raised the following queries:-

- Update on the rehabilitation of the closed landfills at Monanearla and Brittas Road, Thurles.
- Disappointment that only 22 letters issued in relation to the Household Waste Surveys. There is an increase in illegal dumping, one area in particular is at Longford Pass.

It was stated that more stringent action is required to combat illegal dumping of household waste and it should be treated as pollution rather than litter.

- The Roscrea Civic Amenity Site is very well supported but can an update be given in relation to the proposal to extend the site?
- Bin sharing is not working. The Council has paid to clean up in areas
  where individuals have no bins or have bins that are overflowing. This
  should not happen more than once as people are responsible for
  keeping their own households.
- There can be an issue with change of occupation of a house which can cause an accumulation of waste. Refuse collection services are expensive – can a Bin Waiver Scheme such as the scheme in Limerick be considered? Also better engagement between Liaison Officers and tenants.
- Dumping in country roads and in particular on the N62 at the Nore Bridge where 4 bags of rubbish were dumped last week. Can assistance for this issue be requested from An Garda Siochana or other agencies?
- Entrance to Killea Graveyard has been restricted. Stones have been placed on both sides of the entrance which is causing damage to cars and can cause harm to visitors of the graveyard. Why is this allowed to continue to happen?
- Entries for the Tidy Towns Competition are to be submitted by early May. A lot of committees carry out invaluable volunteer work and help should be given to these groups to continue their work. What is the update on the use of technology such as covert cameras and drones. This technology could double up to prevent theft i.e. a recent theft occurred at the Littleton Labyrinth.
- Tipperary County Council Climate Action Plan was brought before the February Plenary Meeting – work being carried out in the decarbonised zone should be done hand in hand with the retro fitting programme for houses within this zone.
- Wall at Fennor Graveyard is still awaiting repairs.

#### Replies to queries raised were as follows: -

- Illegal dumping is an issue everywhere in the County. There is excellent work carried out by voluntary groups who are supported by the Council and the results in the Tidy Towns Competition is indicative of this work. Environment Officers investigate complaints and take action where necessary i.e. issue fines, prosecute offenders in Court. The Council are continuing to make people aware but there are a small minority of offenders continuing to engage in indiscriminate dumping.
- Household inspections are one way of identifying problem areas. The Council are working with Household Waste Companies in identifying households who do not avail of a service and those areas are targeted for evidence with which to issue fines/make prosecutions.

- The Council are working with the Waste Enforcement Regional Lead Authority to prepare a code of practice for the use of cctv in the fight against illegal dumping.
- A number of problem areas have been mentioned and they will be brought to the attention of Enforcement Officers.
- There is a proposal for works at the Roscrea Civic Amenity Site to allow for easier vehicular movement on site and it is hoped this will progress during the year.
- Work is actively being undertake to bring resolution to the issues at both Killea and Fennor Graveyards.
- A decarbonising zone is a key part of the Council's Climate Action Plan. There is a working group on the decarbonised zone in Tipperary but they are awaiting guidance from the Government on funding streams. Actions contained in the Climate Action Plan will be progressed.
- Applications for Certificate of Authorisation for both Monanearla and the Brittas Road closed landfills have been submitted to the EPA. The EPA issued a draft decision on the Brittas Road application in August 2023 and the Council submitted representations to the EPA in September 2023 but no final determination has been made. There has been no feedback on the application for Monanearla.

#### 3.2 Update from LAWPRO.

Fran Igoe, Regional Co-Ordinator and Mags Morrissey, Senior Community Water Officer of LAWPRO were in attendance for this item. A Local Authority Water Programme (LAWPRO) Briefing Note for Thurles MD for April 2024 was circulated to the Members, with the Agenda, in advance of the Meeting. Fran outlined the main points contained in the Report.

The Members raised the following issues:

- Could a public walkway development be undertaken along the River Suir similar to that at the River Ara in Tipperary town. The River Suir is a great asset to Thurles town.
- Update on the weir at the Church grounds in Roscrea. This is an ongoing issue for some time which requires attention.
- There are no signage, litter bins, life buoys at the Ladies Well Walkway in Thurles. A local group look after this walkway but need assistance. Recently the entrance gates were stolen. The walkway is not maintained by the Council but an initiative is required to provide a better service.
- What work is permitted by Drainage Committees under current legislation – the Black River has a lot of silt / vegetation and work is required.

- LAWPRO's priority is water quality. There is a need to promote sustainability on greenways and there needs to more co-ordination on routes. Active Travel and Bord Failte work as a collective for best practice.
- Fran will check if work at the Weir in Roscrea is on the list of works and will revert to the MD once funding is formally announced.
- Anti-social behaviour is a problem for all walkways. LAWPRO have no resources for maintenance of walkways but work with Councils and communities through public community meetings.
- Drainage works on rivers are taken case by case. Fran will discuss the works required at the Black River with the Inland Fisheries.

#### 4.2 District Engineer's Report.

An updated District Engineer's Report for the MD was circulated to the Members in advance of the Meeting and taken as read.

The District Engineer acknowledged that a large number of CRM's were received regarding potholes and staff were working through the list.

The Members raised the following queries:-

- Better signage and road markings required at the junction at Mary Willies pub as it is extremely dangerous.
- Road markings also required in housing estates in the District.
- There is a significant pothole in Willowmere Drive, Thurles that needs attention.
- On completion of the work at Bowes Corner, it had been agreed that a
  pedestrian crossing would be installed on the Abbey Road side of the
  bridge. There is no safe place to cross from the Kennedy Park
  roundabout to the bridge. What is the update on this?

- Disability parking in Templemore and Borrisoleigh is very poor.
- Parking around the Garda College in Templemore is a problem.
- The N62 in Roscrea is in poor condition. Dis-satisfaction with the response given at the Plenary Meeting as the work is not scheduled until 2025 / 2026. There needs to be a push to get this work carried out sooner.
- Update on provision of bus shelters in town centres in the MD.
- Speeding in Knock Village where there was a near incident last week involving a child. There is a long stretch of road through the village. Flashing signs had been installed but are not working. The Council need to be proactive to move to next stage to address this issue. The Committee are available to liaise with the Council on this matter.
- When will work be carried out at the main entrance to Thurles Railway Station (on Streamline side of bridge).
- The former District Director gave a commitment that lights would be installed at Orchard Court Templemore – what is the current position in this regard?
- Road off the N62 toward the Water Treatment Plant is in poor repair works had previously been carried out on part of the road.
- Parking problems at Church of Ireland, Bournea, Templemore. Can
  urgent works be carried out by the Council or communication be made
  with the Church of Ireland who will carry out the necessary works.
- Speeding in the Cabra/Ballycurrane area, Thurles. Can speed surveys be carried out here and also in Butler Avenue, Thurles? Can structural work such as build-outs be installed to slow down drivers?
- Can increased signage be erected in Kilcooley Way near Gortnahoe?
- Update on the request for additional parking in Cabragh Court housing estate, Thurles.
- As there is no current scheme for work on back lanes in Thurles, particularly Kennedy/Collins Park, can this work be included as part of the Roads Programme?

## Replies to queries raised were as follows: -

- A speed limit review is being undertaken and we are waiting on Department guidance regarding same.
- Correspondence was issued to the Members regarding back entrance works which is an ongoing problem. Repairs/maintenance of back entrances cannot be included in the Roads Programme.
   The District is currently piloting a scheme whereby residents on these laneways contribute 25% of the overall cost of the works and the MD will fund the remaining. The number and scale of back lanes completed each year will however be limited due to budget constraints and resources.
- Provision of additional parking and signage at Cabragh Court housing estate, Thurles will be examined.
- Due to current weather conditions, road markings will not be renewed but this work will be carried out when weather improves.

- Contact for the Church of Ireland to be given to District Engineer re parking at Bournea, Templemore.
- The road to the Water Treatment Plant Templemore will be examined.
- A meeting will be arranged with the Knock Village Committee regarding speeding in their village. The problem is the mindset of some drivers and non-compliance with rules. The issue will also be referred to the Gardai.
- Update on N62 will be sought from the TII.
- The issue of bus shelters in the MD was previously investigated under Active Travel, however, a location that met the criteria for such a project could not be identified. The issue can be revisited.
- The provision for disability parking in urban settings will be delivered through the proposed review of parking by-laws.
- Contact will be made with the Garda College Templemore on the overflow of parking taking place at the moment.
- There are a number of Part 8 proceedings in the coming weeks and once these are completed, priority will be given to progress a junction design at the Templemore Junction in Borrisoleigh.
- Section 38 and CE Report have been prepared for work at Abbey Road,
  Thurles however there is a significant shortfall in funding and an
  alternative source is being investigated. A contractor is lined up to
  carry out this work. Work at Abbey Road will not commence until
  work is complete at The Ragg and is also subject to funding.
- Grants received from the Department have not increased so effectively the MD are trying to do same work with less money.
- Pothole at Willowmere Drive Thurles will be added to overseer's list for that area.
- There has been a 50% cut in funding from IPB for footpath repairs.
- Road markings / signage at Mary Willies will be examined.
